1. The websites and information covered by this Privacy Policy

This Privacy Policy applies to information we collect through (a) the website located at www.konami.com/games/us/en/; (b) all related Konami-controlled websites (example: <https://us-support.konami.com/>); (c) our pages on social media websites such as Facebook and Twitter (the "Konami Social Media Pages"); and (d) our other online products or offerings. Collectively, the foregoing items (a) through (d) shall be referred to as the "Online Services". Please note that through our Konami Social Media Pages, we may collect personal information from you in accordance with this Privacy Policy; however, this Privacy Policy does not govern the collection, use or disclosure of your information by any third party, when the collection, use or disclosure takes place directly through that third party's

platform (e.g., web pages or apps hosted by Facebook and Twitter. We recommend that you review the privacy policies of these third parties. WE ARE NOT RESPONSIBLE FOR THE INFORMATION COLLECTION, USAGE, DISCLOSURE, OR SECURITY POLICIES OR PRACTICES OF SOCIAL MEDIA PLATFORMS OR ANY OTHER THIRD PARTY.

Some jurisdictions may require notice concerning personal information collected offline; for those jurisdictions, this Privacy Policy also explains our practices regarding personal information that we obtain from offline sources, or information you provide to participate in an offline promotion or to attend or participate in Konami Tournaments (as defined below).

2. What types of personal information does Konami collect and how will it be used?

“Personal Information” is information that is linked or reasonably linkable to an identified or identifiable individual, household, or device.

Konami may collect personal information about you when you use the Online Services or our products or services, or when you otherwise provide personal information to us. For example, we may obtain personal information through: (1) product registration; (2) purchases; (3) email correspondence with customer service; (4) the Konami Social Media Pages; (5) the Konami Judge Portal; (6) information submitted in an employment capacity (e.g., resumes); (7) information submitted as part of a promotion (e.g., through your participation in online contests or sweepstakes); (8) your opting-in to participating in interactive SMS/Text experiences or promotions; (9) your opting-in to receive our e-mail newsletters; and/or (10) community registration and tournaments. The types of information that may be requested for each activity and the way the information may be used are detailed below.

No matter what method we use to collect information and no matter how we use that information, we seek only to collect the information that we believe is reasonably necessary to fulfill your requests and our legitimate business objectives.

§ Product Registration

To register a Konami product online, you will be required to submit your first and last name, city, state/province, zip/postal code, country of residence, email address, date of birth, age. You may also be asked to provide your phone number and answer questions relating to information about the product you purchased, the type of console you own, and the types of games you enjoy playing. The information that you submit during product registration will entitle you to limited warranty protection and technical support.

§ Purchases

If you purchase from us, we will collect your name, email address, phone number, shipping & billing address, and payment card information. We will use such information to complete your transaction and process returns and exchanges, as well as for related customer service.

§ Customer Support

Konami may collect, use and store personal information that you voluntarily submit to us via email or other means when interacting with Konami customer service. For example, we may provide on the Online Services a link through which a visitor can email to customer service addressing any issue a user encounters with a Konami product. Your email address and any personal information you choose to provide in the body of such email is used by Konami for purposes of addressing and responding to your question.

§ Konami Social Media Pages

You do not have to provide personal information to use the Konami Social Media Pages. However, in order for you to take advantage of particular opportunities provided through the Konami Social Media Pages (for example, promotions, events, or games), we may require that you furnish personal information. This information may include your name, postal address, telephone number, email address, Facebook and other social media IDs and the names of your friends, but only when you voluntarily provide it to us (either directly or indirectly, such as a result of your authorizing Facebook or another social media platform to send it to us). Konami also collects other information from the Konami Social Media Pages (such as your gender, social media networks, workplace, geographic location, application settings and statistics, status updates, user and interactions) when you voluntarily provide such information to us (either directly or indirectly, such as a result of your authorizing Facebook or another social media platform to submit such information to us).

§ Konami Judge Portal

Konami may collect, use and store personal information that you choose to provide when you use our Judge Portal for training, support and guidance, or to become certified and register as a judge. This information may include your name, contact information, username/password, Card Game ID, birthdate and languages spoken. We may use this information to fulfil your requests, communicate with you, and to certify, register and support you on your journey to becoming a judge.

§ Candidates for Employment

Konami may provide on the Online Services an email address that visitors can use to send us their resumes. We also may collect personal information offline about candidates for employment. Personal information about candidates will be used for the purpose of accepting and evaluating candidate submissions for job postings and may therefore be shared within our company. If the candidate becomes an employee, this information also may be used and retained for employment purposes.

Other than as explained in this paragraph, this Privacy Policy does not apply to personal information gathered concerning job applicants or candidates for employment.

§ Promotions

From time to time, we may offer you the opportunity to enter into Konami-sponsored promotions, such as contests or sweepstakes. We may offer these promotions online or offline. To participate in a promotion, you may be required to submit information, such as your first and last name, city,

state/province, zip/postal code, country of residence, email address, and date of birth, so that we (or our partners) can administer the promotion. For example, we (or our partners) may use this information to determine whether you are eligible to participate in the promotion and/or to notify you in the event you are selected as a winner.

§ Interactive SMS/Text Experiences

From time to time, we may offer users who are 18 years of age or older interactive phone and SMS/text campaign experiences, such as alternate reality (ARG) activations. If you decide to participate in such activations, we will collect your name, phone number, your keypad selections and responses within the experience, technical details relating to message delivery (e.g., message timing and delivery status), and your replies to messages we send (e.g., opt-in, opt-out, or help requests). We will use this information solely to operate the experience, for example, to send messages, respond to your keypad selections, confirm delivery, honor opt-out requests, and measure campaign performance. You may opt out of these communications at any time by texting STOP or by contacting Konami Customer Support.

§ E-Mail Newsletters

Konami may provide on the Online Services the opportunity to sign up for e-mail newsletters regarding specific Konami services and products. If you decide to sign up for a Konami e-mail newsletter, we will collect your first name and e-mail address and country of residence, as permitted by law. We will use your first name and e-mail address to provide to your chosen e-mail address the Konami e-mail newsletter(s) you have opted into. We will use your country of residence information to provide you with product and service information, including information relating to any marketing promotions or campaigns, that is appropriate for your country of residence. If at any time you would like to unsubscribe from receiving future e-mails from our e-mail newsletter(s), we include detailed unsubscribe instructions at the bottom of each e-mail or you can contact Konami Customer Support to place an unsubscribe request.

§ Community Registration and Tournaments

If you choose to participate in Konami tournaments, including, but not limited to, tournaments for Yu-Gi-Oh! TRADING CARD GAME or eFootball (collectively, "Konami Tournaments"), you may be required to provide us with certain information, including, but not limited to, your first and last name, street address, city, state/province, zip/postal code, country of residence, phone number, email address, date of birth, age, Card Game ID (for Yu-Gi-Oh! tournaments), a user name, user ID, password, and/or passport number (if required for travel arrangements), depending upon the Konami Tournaments which you participate in. The information that you submit during registration will: (a) make up your profile; and (b) allow you to participate in Konami Tournaments, player ranking systems, and otherwise track your participation in the Online Services. If the Konami Tournament has a monetary prize, winners may be required to provide their bank account information for the purpose of receiving the monetary prize only. We retain this information only for as long as reasonably necessary to administer the applicable tournament(s) and related participation, after which it is deleted or de-identified in accordance with our retention practices.

For the Yu-Gi-Oh! TRADING CARD GAME, please note that Konami's invite list or TRADING CARD GAME suspended player list that shows invited players' or suspended players' first name, last initial, last four digits of Card Game ID and country of residence may be publicly displayed online for a limited period. Such lists are removed once the applicable World Championship Qualifier has concluded.

When attending or participating in Konami Tournaments, your photographic likeness, name, country of residence, age, or other information may be used in print, photo, livestream, and digital media as part of event coverage. We cannot and do not guarantee that this information will be kept confidential or private. If you have questions or concerns regarding the use of your information in connection with a tournament or event, you may contact Konami for assistance by submitting a request through our support portal at <https://us-support.konami.com/hc/en-us/requests/new>.

§ Passive Collection

As noted below, (see "Does Konami use cookies, track IP addresses or use other passive means to collect information?"), we use certain passive means to collect information regarding visitors' use of the Online Services. We may use and disclose such information, as well as aggregated information or other non-personal information, for any purpose.

§ Other Uses of Personal Information

We may also use your personal information for our internal marketing and analytics purposes, so we can constantly improve our products and services and better meet your needs.

Cross-Border Transfer

Your personal information may be stored and processed in any country in which we engage service providers, and by using the Online Services, you understand that your information will be transferred to countries outside your country of residence, including the United States, which may have different data protection rules than in your country.

3. What happens if I refuse to provide my personal information to Konami?

If you choose not to submit personal information when requested, you may not be able to participate in certain activities, which may considerably limit the services we can provide you.

4. Does Konami use cookies, track IP addresses or use other passive means to collect information?

Cookies

Konami may collect information through cookies to improve your use of the Online Services. A "cookie" is a small string of text sent by the Online Services to your browser and then stored by your browser on

your computer's hard drive. Storage of cookies on your system provides an easy and convenient method for us to personalize and enhance your experience on the Online Services, and to help us diagnose problems with our servers and to administer the Online Services. For example, cookies allow us to remember your screen name and date of birth, tell us that you have visited the Online Services before, track your usage of the Online Services, and make your next visit to the Online Services more enjoyable. Most web browsers automatically accept cookies, but you can always disable cookies or set your browser to alert you when cookies are being sent to your computer. However, rejecting cookies may prevent you from taking advantage of certain portions of the Online Services.

Third Party Cookies

We and our third-party service providers may use cookies and similar technologies to manage and optimize our Internet business and communications, such as for marketing purposes, to help us deliver advertisements, to measure the effectiveness of our advertising, and to understand how visitors use the Online Services. These technologies may collect users' browsing and other traffic activity; the date and time of visit; and product codes and pricing information for purchased merchandise. This information helps us learn things like what pages are most attractive to our visitors, which of our products or Online Services most interest our customers, and what kinds of offers our customers like to see. Although our third-party service providers log the information coming from the Online Services on our behalf, we control how that information may be used. You may be able to "opt-out" of our ability to analyze such data. For more information about our third-party service providers, please see the information here.

We use Google Analytics, which uses cookies and similar technologies to collect and analyze information about use of our websites and report on activities and trends. This service may also collect information regarding the use of other websites, apps, and online resources. IP Addresses

While you are browsing the Online Services, Konami automatically collects your IP address, a number that is used to identify your computer when you log on to the Internet.

Log Files

Konami collects information in the form of log files that record activity on the Online Services, including how many "hits" a particular web page is getting (also known as "click data"). For example, log file entries are generated every time a visitor clicks an image on the Online Services. These entries enable Konami to assess overall site activity, track interest in particular portions of the Online Services, troubleshoot technical concerns, and identify the type of browser you are using. We may also use the log file entries for our internal marketing and demographic studies, so we can constantly improve the products and services we provide you.

Do-Not-Track / Global Privacy Control

Users can set privacy preferences through the Do Not Track (“DNT”) mechanism in certain web browsers. In addition, some browsers or plug-ins use a “Global Privacy Control” (“GPC”), which allows you to opt out of certain data processing. (You can learn more about the GPC at <https://globalprivacycontrol.org/>.) Please note that we, like many websites and online services, do not respond to or honor DNT signals or similar mechanisms transmitted by web browsers. If our site detects a GPC signal from your device, however, we will interpret it as either a Do Not Sell request or a request to limit the sale or sharing of personal information for targeted advertising depending on the law applicable to your jurisdiction.

5. With whom does Konami share my personal information?

Except as expressly provided in this Privacy Policy, Konami's policy is to not sell or rent your personal information to third parties.

Konami may share your personal information with its parent, subsidiary, and/or affiliate companies (<https://www.konami.com/corporate/en/subsidiaries/>) for the purposes described in this Privacy Policy, including to allow them to send you information about their own products and services. Konami Digital Entertainment, Inc. is the party responsible for the management of this jointly-used information.

From time to time, Konami may share your personal information with its third-party service providers and/or licensors, to enable them to provide services in connection with the operation, maintenance and/or support of the Online Services. Such services may include, without limitation, message board operation, email delivery, SMS/text message communications and automated call handling for promotional campaign opt-in, product registration, storage, website hosting, data analysis, payment processing, order fulfillment, infrastructure provision, IT support, customer support, credit card processing and web site auditing. These service providers may collect, process, and store personal information directly on Konami’s behalf, and are permitted to use that information only to provide their services to Konami.

By using our Online Services, you may elect to disclose personal information, such as on message boards, chats, profile pages, blogs, and other services to which you are able to post information and content (including, without limitation, our Konami Social Media Pages). Please note that any information you post or disclose through these services will become public and may be available to other users and the general public.

We may use and disclose the information we maintain, including personal information, (a) when required to do so by law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from a law enforcement agency or public or government authority, including outside your country of residence; (d) to enforce our terms and conditions; (e) to protect the

rights, property, or safety of Konami, our customers, users of the Online Services or others; and (f) to allow us to pursue available remedies or limit the damages that we may sustain.

In addition, Konami may disclose personal information and other information we obtain from you to a third party in the event and/or consideration of a reorganization, merger, sale, joint venture, assignment, transfer, or other disposition of all or any portion of our business, assets, or stock.

6. What is Konami's policy regarding Children?

Konami does not permit users under 13 years of age ("Child" or "Children") to become registered users of the Online Services. We do not knowingly collect Personal Information from Children through the Online Services if such collection would require parental consent under applicable law. We may collect information from parents or legal guardians about Children, and in certain limited circumstances, from Children such as for Yu-Gi-Oh! as set forth below. In addition, as explained above, we and our service providers automatically collect IP addresses and other technical information through the use of cookies, solely to support our internal operations, such as to analyze how the Online Services are used. For more information about our third-party service providers, please see the information here. § Children's Privacy: Yu-Gi-Oh! Products and Services

This section describes how we collect, use, and retain Personal Information from or about Children online in connection with Yu-Gi-Oh! products and services.

Information We Collect From or About Children

We collect Children's Personal Information online only in the limited circumstances described below and only for purposes related to the applicable activity.

(1) Tournament

Registration

As described above, Konami does not permit Children to become registered users of the Online Services. Personal Information about Children is collected only from their parents or legal guardians.

When a parent or legal guardian registers a Child for a tournament, we may collect the following information about the Child:

- Child's name
- Card game ID

- Date of birth
- Country of residence

This information is used solely to administer tournament participation, including verifying eligibility, maintaining tournament records, and communicating with parents or legal guardians regarding event-related matters. We do not require parents or legal guardians to provide more Personal Information about their Children than is reasonably necessary to participate in a tournament.

Photographic Likeness and Voice

As part of tournament participation and event coverage, Konami may collect a Child's photographic likeness and voice. Our collection of a Child's photographic likeness and voice is reasonably necessary for the administration of tournaments, including to authenticate participants, recognize winners, and to display event-related content on Konami-controlled websites, applications, and social media channels. At the time of registration, we will ask parents or legal guardians to provide verifiable consent through a signed written consent form for the collection and use of this information.

Tournament Winner

In limited circumstances, and only when a Child is selected as a tournament winner, we may collect the following Personal Information about the Child from the Child's parent or legal guardian, solely as necessary to administer prizes or arrange travel:

- Full address
- Home store
- Personal identification, including a passport, only where strictly necessary for travel purposes and only in cases where Konami arranges and pays for the Child's travel to participate in a tournament. The specific information collected may vary depending on the tournament.

We and our service providers automatically collect IP addresses and other technical information through the use of cookies, solely to support our internal operations.

The persistent identifiers we collect are as follows: IP address

We use these identifiers to maintain and analyze the functioning of the Online Services, perform network communications, maintain the security and integrity of the websites, user and Online Service, detect or prevent fraudulent or abusive activity, and ensure legal and/or regulatory compliance.

We implement policies and procedures, including safeguards relating to personal training, data segregation, and data access, storage and retention, to ensure that any persistent identifiers collected from Children are not used to target a specific Child, including through targeted/behavioral advertising, marketing, or profiling purposes.

Retention of Children's Personal Information

We retain Children's Personal Information only for as long as reasonably necessary to fulfill the specific purpose for which it was collected and do not retain such information indefinitely.

- **Registration and Tournament Winner Information:**

Information collected from parents or legal guardians in connection with tournament registration and, where applicable, tournament winner administration is retained only for the period reasonably necessary to administer the applicable tournament(s) and related participation records, including resolving eligibility questions, maintaining historical competition records, and addressing disputes or inquiries related to the event, after which it is securely deleted or deidentified.

- **Photographic Likeness and voice:**

Photographic likeness and voice collected with parental or legal guardian consent are retained only for so long as reasonably necessary to support the purposes described above, including maintaining event records and related content. Parents or legal guardians may withdraw consent and request removal of such content at any time, and upon receipt of a valid request, Konami will take reasonable steps to remove or disable access to the content within a reasonable period.

- **Website IP Addresses:**

IP addresses collected through the Yu-Gi-Oh! websites are retained for up to 30 days, based on our operational need to support website security, performance monitoring, and fraud prevention, after which they are automatically deleted.

When Children's Personal Information is no longer reasonably necessary for its original purpose, we delete it using reasonable measures designed to protect against unauthorized access or use during deletion.

Parental Rights

Parents and legal guardians may review, request correction or deletion of, or refuse further collection or use of their Child's Personal Information as described elsewhere in this Children's Privacy section at <https://us-support.konami.com/hc/en-us/requests/new>.

12. Brazilian General Data Protection Law

This section is applicable to the processing of personal information subject to the Brazilian General Data Protection Law (Law No. 13,709/2018, the “LGPD”, as amended), that is, whenever: **(i)** data processing takes place in Brazil; **(ii)** the processing activity is intended to offer or supply goods or services or to process data of individuals located in Brazil; or **(iii)** personal data being processed was collected in Brazil (including data collected of data subjects that were in Brazil at the time of collection). Any terms defined in the LGPD have the same meaning when used in this section.

12.1. Your Rights

The LGPD gives you specific rights to your personal information, as described in Article 18 et. seq. of the LGPD. This section describes your rights and explains how to exercise them.

- Right to confirmation and access: right to obtain confirmation that your personal information is being processed, and the right to access such data.
- Right to correction: right to request correction of incomplete, inaccurate, or outdated personal information.
- Right to anonymization and deletion: right to request the transformation of personal information into anonymized data and to delete unnecessary or excessive personal information, or of personal information processed in noncompliance with the provisions of the LGPD.
- Right to portability: right to request that your personal information be transferred to another service or product supplier, according to Brazilian Data Protection Authority’s (“ANPD”) regulation, provided that the trade and industrial secrets are respected.
- Right to obtain information about the entities with whom the personal information is shared.
- Right to withdrawal consent: if the processing requires the granting of consent, you may withdraw such consent at any moment and, subsequently, request the deletion of such data.

- Right to obtain information about the possibility of not providing consent and the consequences of denial.
- Right to deny: right to deny data processing of personal information, in case the processing is not in compliance with the LGPD.
- Right to request the review of decisions taken solely by automated processing (without human intervention) of personal information, and such processing could affect your interests.

We retain Personal Information for as long as needed or permitted in light of the purpose(s) for which it was collected. The criteria used to determine our retention periods include:

- The length of time we have an ongoing relationship with you and provide services to you (for example, for as long as you have an account with us or keep using our services) and the length of time thereafter during which we may have a legitimate need to reference your Personal Information to address issues that may arise;
- Whether there is a legal obligation to which we are subject (for example, certain laws require us to keep records of your transactions for a certain period of time before we can delete them); or

- Whether retention is advisable in light of our legal position (such as in regard to applicable statutes of limitations, litigation or regulatory investigations).

In certain circumstances, we apply specific retention periods as follows:

- **Inactive or Abandoned Accounts:** We will delete inactive or abandoned accounts and associated Personal Information within a reasonable period consistent with product lifecycles and consumer expectations, but in any event no more than six (6) years. Before deletion, we will provide an opportunity to maintain the account or, if relevant, to download applicable data.
- **Incomplete Accounts:** If you begin but do not complete an account registration or purchase, we will delete any Personal Information collected within two (2) weeks.
- **Customer Service Data:** Personal Information contained in customer service communications (such as emails, chat logs, and recordings) will be deleted or de-identified after one (1) year, unless longer retention is required for content moderation, trust and safety, or the detection, investigation, or prevention of fraud, cheating, piracy, or other abuses.
